itv Council Update

Mayor Pam VanArsdale opened the October City Council meeting welcoming Pastor Sharon Boland with Hope Alive Foursquare Church to deliver the Invocation. Following Pastor Boland's Invocation 6) A request from the League of Oregon Cities the Mayor led the City Council and audience in the Pledge of Allegiance. The Mayor then asked the City Councilor's for their Committee Reports.

The following items were on the October agenda:

- 1) A Public Hearing was held to hear citizens comments regarding a request to hook up City Stiehl Lane. The property had been provided with water services for many years and the City Council found it to be beneficial to the City to allow the applicant to hook up to sewer eliminating a leach field that was located in the City.
- 2) A Retainer Agreement between the City and Steven E. Rich, Attorney at Law was approved and the Mayor was authorized to sign the agreement.
- 3) A First Amendment to the ODOT Loan Agreement, Series 2013A, Bond No. 1 and Series 2013B, Bond No. 2 amending the Project Completion Date and the Project Completion 9) Deadline was approved and the Mayor was authorized to sign the amendment.
- 4) A new Liquor License Application for limited on premise sales for the Rogue Burrito, located at 308 East Main Street was approved and the Mayor was authorized to sign the application. Applicant: Josh Terranova, owner.
- 5) An Oregon Liquor License Renewal for

Off-premise Sales for A1 Market #11 located at 8981 Rogue River Highway. Applicant: Ashok Bala, LLC.

- (LOC) Foundation Board to contribute to their scholarship fund benefitting scholarships for the Mayors Association and the LOC Conference and training workshops. Many times the City has been a recipient of these scholarships and approved to pay the \$1 per capita totaling \$110.
- sewer services outside the City limits at 200 7) A request from Southern Oregon Sanitation (SOS) for support in obtaining a waiver from the Oregon Department of Environmental Quality (DEQ) to landfill recyclable materials collected within Jackson County during the current recycling market crises. Trent Carpenter with SOS told the City Council their process for dealing with the crises and the City Council approved to support SOS in their endeavors.
 - 8) A resignation from Planning Commissioner Evan Goeglein effective November 1, 2017 was accepted with deep regret and a vacancy was announced.
 - A recommendation from the Tree City Committee was approved to appoint James Alan Dyck to the committee.
