Smoke Testing Announcement

The City of Rogue River has contracted Civil West Engineering Services to perform a smoke testing survey of the City's wastewater collection system. Smoke testing activities are tentatively scheduled to occur between Wednesday, September 13th and Friday, September 15th 2017.

Smoke testing is an efficient and cost-effective way to identify system leaks and locations where unwanted storm water may be entering the sanitary sewer. These problem areas can be identified as smoke escapes through holes in the system and are observed above ground by survey personnel.

During testing, residents may notice smoke escaping from roof vents, clean outs and manhole lids. Smoke from these areas is expected and appropriate. Smoke may enter a structure if plumbing issues exist, such as faulty or improperly installed P-traps or drains. To minimize the smoke entering your house, please pour water into all drains including floor drains prior to the testing. The smoke is non-toxic, non -staining, and non-flammable, however if smoke enters a structure please notify City Hall or the smoke testing survey crew.



The presence of the smoke in a structure can be an indicator that there are dangerous and toxic gases entering your house from the sanitary sewer. If you notice smoke in your house or on your property <u>PLEASE REPORT IT</u> immediately to the personnel conducting the testing survey or call the City of Rogue River at (541) 582-4401.

MAYOR'S CORNER

We have received numerous complaints lately regarding cats. These complaints have come in from various locations throughout the city. The complaints are all very similar though – neighbors that have in excess of a half dozen outdoor cats that do their business in peoples' yards, flower beds, and even children's sand boxes. Many of these cats are strays that are being fed by "well intentioned" folks. According to Jackson County Animal Control, if you feed a stray cat for more than 30-days, it is no longer a stray and is now considered your pet. Most of them are not spayed/neutered and continue to have litters that add to the excessive number of cats roaming our neighborhoods. And many of these strays carry diseases such as feline leukemia and feline HIV.

The City Council is considering what action they should take. We would like to get some input from all you – not just more complaints but some ideas of what can be done. Do we require all cats in the city be licensed, just like dogs? Should we limit the number of household cats a person can have in the city limits? Require owners of outdoor cats to provide an outdoor litter box? What other solutions could best address the problem without creating a burden for the responsible pet owners?
