APPROVAL OF MINUTES:

MOVED (SPENCER), SECONDED (CATHERWOOD) AND CARRIED TO APPROVE THE MINUTES OF FEBRUARY 27, 2014 AND MARCH 27, 2014.

COMMITTEE REPORTS:

Finance Committee: City Councilor Earl Shamblin reported that they met twice to review bills and sign 74-checks in the amount of \$90,574.30 during the month of March 2014 and after reviewing the finance report the City was doing well.

<u>Planning Commission Liaison</u>: City Councilor Mark Poling reported that they

reviewed the map amendment for zoning changes, they discussed Phase II Final Plat for Foothill Estates extension and they okayed a parking lot agreement between TLC Chiropractic and the Double R Pub.

<u>Community Relations</u>: City Councilor Shelli Spencer reported that the Chamber of Commerce was doing some restructuring and things were moving forward in a positive direction, the Community Center was doing well, upgrades included new counter tops in the kitchen area and the Greenway was moving forward with Ride the Rogue and was looking to fill three board member positions.

PUBLIC INPUT:

Robert Smith of Magerle Drive handed out a typewritten 4-page document regarding comments made at a previous meeting but did not address the item. He did give an update on the drug situation on Magerle Drive stating that someone had stopped to say he liked his guy hanging in his yard saying that his mother told him that the people were living in two nearby homes. A few days later he said a group of thirteen year old kids had come by on skateboards and he asked them what they thought of his sign? He said they replied, don't do meth. He said he had recently seen police cars patrolling in the area so he was seeing an improvement. He said they are back up to it again though, they seemed to take a hiatus after the sign went up and articles in the paper. He commented on research he had done for a book he published in the 1970's and the Center for Disease Control published a yearly mortality schedule causes of death in the United States and drug overdose was one of them. Since 1967-2012 over 600,000 people in the U.S. had died from drug overdoses and research indicated that in the U.S. and Europe for every person that died from an overdose at least two more died of related causes such as murders. diseases, organ failures, etc. Those were not counted but if you added those numbers up there would be more than 2-million deaths since 1967 from drug use. He said that number was more than all the wars the U.S. had ever fought.
