COMMITTEE REPORTS:

Community Relations: City Councilor Sheili Spencer reported that the holiday events went well.

<u>Finance Committee</u>: City Councilor Bob Catherwood reported that they had met twice during the month of November to review and approve the bills and signed 69-checks totaling \$127,659.46.

Police Commission: City Councilor Fred England reported that the department had been very busy, that a new officer would be starting on January 8, 2018 and that they had delivered two of the new cars. He also commented that they were still looking for another officer and with the low level of officers the department had been feeling the stress.

Rogue Valley Area Commission of Transportation: City Councilor Fred England reported they discuss aviation issues in the valley, funding for restrooms at the Ashland Airport, and fuel card lock systems.

Rogue Valley Council or Governments (RVCOG): Mayor Pam VanArsdale reported they had discussed Shake Down and how they would address only a 90-second warning for shutting down computers, utility plants and more.
