

#### **AGENDA ITEM 1**

Public Hearing: CUP 2017-01 Continued Conditional Use Permit and Site Plan Review to conduct cannabis processing. The property is described as T.36S. R.4W., Section 22B, Tax Lot 503, located at 5432 North River Road, Rogue River, Oregon. Applicate: Niles Christodoulidis, Rebel Roots Farms

Vice Chair Dean Stirm declared the public hearing is now open at 6:04 p.m. as a continued public hearing and the script will not be read again.

City Planner Dick Converse presented the Staff Report which is a permanent part

of the land use file for T36S, R4W, Section 22B, Tax Lot 503 located at 5432 River Road. Converse notified the commission that the applicant Niles Christodoulidis has submitted the driveway easement between the two adjacent owners.

Applicant Christodoulidis was asked to come before the commission with a presentation. Christodoulidis thanked the commission for all of the patience all through this project and was looking forward to become a part of the community.
